

**MONONA COUNTY BOARD OF SUPERVISORS MEETING
OCTOBER 14, 2025**

The Monona County Board of Supervisors met in regular session at 8:30 a.m. o’clock on Tuesday, October 14, 2025, in the boardroom of the courthouse in Onawa, Monona County, Iowa with Chairman Fox presiding. Other Supervisors present: Tom Brouillette and Vince Phillips. Supervisor Absent: None. Also present was Auditor Peggy A. Rolph.

Motion was made by Supervisor Phillips, seconded by Supervisor Fox to approve the agenda. Vote on motion: Ayes: Fox, Brouillette, and Phillips. Nays: None. Motion carried.

Keith Madsen was present for public comment regarding his fence being fixed because of the trees that were removed by Secondary Roads. Discussion followed. No action taken.
